1.	With regards to Single Largest Completed Contract (SLCC), what if the total amount of the contract has other devices? But its relation or it is related to security like CCTV? The total amount.	As regards to the query, the requirement is specific. It should be similar although related to the subject we are procuring.
2.	So the CCTV is not included in the similar?	Yes.









3. About the screen of the control terminal, the requirement is only 5". Is it possible to increase it to 7" or the standard only is 5"?	5" is the minimum, but it is suggested that interested bidders should conduct an ocular inspection on the site to determine whether 5" would do or a bigger measurement would be needed, as long as your bid would fall within the ABC. The same shall be accepted.
What is the usual employee count in one branch within Bacolod?	Basically the biometrics will not be used by our branches. This will be deployed to one of our clients which is the LGU Bacolod City and their employee count is 1,500 to 2,000.
5. Is it possible to lower the log capacity as it is a bit too much for certain population of 1,500 to 2,000 employees?	The capacity was set not for the present condition but in anticipation for the increase in the number of employees as prescribed by our end user which is the LGU.
6. Regarding the submission of bids, if we prefer to submit it manually, is it ok to submit it via courier or required that a representative from the company will be the one to submit since from Metro Manila?	There are manners of submission of bids. It can be submitted manually or thru electronic means.  As to the query specifically on sending your bid docs thru a courier. You can send your bids thru courier but at your own risk and any delay attributable to your courier would not be a cause or a reason for you to have a special consideration during the opening of bids.
